Client(s) agree that an entire wedding cannot be replicated, reenacted or repeated for the purpose of a re-shoot and limits Stacy Nish's liability to the amount paid under this contract. It is also understood that Stacy Nish is not responsible for any injuries or damages that may be caused during the photo shoot.
