It is illegal to copy or reproduce these photographs elsewhere without photographer's permission. **The images are not licensed for commercial use or competition. The images are a finished work and are not to be altered in any way.**

If Photographer cannot perform this Agreement in whole or in part due to any reason or cause beyond the control of the parties or due to Photographer's illness or injury, then Stacy Nish will return all fees to the Client(s) but shall have no further liability with respect to this Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Photographer. Client(s) agree that an entire wedding cannot be replicated, reenacted or repeated for the purpose of a re-shoot and limits Stacy Nish's liability to the amount paid under this contract. It is also understood that Stacy Nish is not responsible for any injuries or damages that may be caused during the photo shoot.

Upon signing of this agreement by both parties hereto, Stacy Nish of Stacy Marie photography will reserve the time agreed upon and will not make another reservation for the specific time frame. For this reason, **all deposits are non-refundable** due to client cancellation, even if the date is changed or if the wedding becomes cancelled for any reason.

The service fee is \$ \_\_\_\_\_ and includes \_\_\_\_\_ hours of wedding day coverage, and all images from the wedding day, fully edited, in high resolution digital format with a print release. A deposit of \$ 250.00 is due at the signing of this agreement, with a further payment of all necessary expenses (unless otherwise specified) including, but not limited to: parking, fuel, travel, accommodations, entrance fees, etc. (when applicable), to be paid on or before the day of the wedding. **The deposit is non refundable in case of cancellation or date change by client. If Client cancels within one month of wedding date, they are responsible to pay the full service fee amount.** No photography will take place and no rights are granted until timely payment is made in full. Late payment fees may apply. Please allow **up to four weeks from wedding date to receive photos. Photos can be rushed for an additional price.**
